AWAKENING 2014 Vending & Display Tent Application & Agreement

Awakening 2014 has limited space available for vendors or organizations interested in displaying information or selling approved products during the AWAKENING 2014 MUSIC FESTIVAL, September 13, 2014 at Bull Run Park, Centreville, VA. Please read this agreement fully, and complete all information regarding your organization. Remember to send in all payments with your Vendor Agreement & Vendor Information Form. A copy will be sent back to you once this agreement is approved and signed. (Enclose payment with paperwork & keep a copy)

AWAKENING 2014 Date & Set Up Hours:

(Set up: Saturday, Sept. 13th, 7:00am - 10:00am)

All set up must be complete by 10:00am.

*****NO VEHICLES WILL BE ALLOWED INSIDE THE GATES AFTER - 9:30am - YOU WILL NEED TO UNLOAD AND PARK OUTSIDE OF THE FESTIVAL FENCE.**

EXHIBIT HOURS:

Saturday, September 13th - (Tent opens 10:00am - closes 10:00pm)

1. **VENDING BOOTH SIZE:** Each booth is approximately 8' X 8' and located in the large vending & display tent situated at the rear of the amphitheater. The vending and display tent will be located in a high traffic area between the food vendors and the main entrance.
2. **VENDING BOOTH RENTAL FEE:** Each booth space costs \$300.00. This cost includes two (2) Event Vendor Passes, One (1) table (8' long), and two (2) chairs. Electric will be available - must request in advance. Table skirts will be supplied by AWAKENING and are required.
3. **Taxes:** As a vendor, you are responsible for collecting any and all applicable taxes. The festival will not assume any responsibility for state, local, or federal inspection or taxes required.
4. It is agreed that you, the Booth Holder, will hold harmless Awakening Ministries, Inc. (sponsor of the Festival) from all claims and liabilities for damage to property or injury to persons that occur in or about the rented or used booth space, or any failure to act, whether or not such condition, activity or failure shall result from negligence of the party renting or using the space.
5. Applications will be received and either approved or rejected. You will be notified by mail of our decision within two (2) weeks after receiving your application. Acceptance is based on the quality of your merchandise as well as type of merchandise. No Merchandise that has the name or logo of the Awakening Festival is allowed to be sold or given away, No food, candy or beverage items can be sold or distributed in any way by product vendors. If your application is not accepted, your rental fee will be returned.
6. There will be no cancellations after August 15th, 2014. If a cancellation should occur prior to August 15th, your deposit will be returned, minus a \$50.00 non-refundable fee. Upon receiving this application and it's subsequent approval, the festival management will send your copy of this application back to you.
7. The deposit due is the cost of the booth space(s) (\$300.00 per booth), extra registrations beyond the two (2) will need to purchase tickets from our website.

8. **INSURANCE:** It shall be the responsibility of the exhibitor to secure necessary insurance coverage. The exhibitor acknowledges that Awakening Ministries, Inc. doesn't maintain insurance covering the exhibitor's property and it is the sole responsibility of the exhibitor to obtain business interruption, property damage, and liability coverage covering any such losses or claim.
